 Widen the existing bridge to a 5-lane roadway section over E-470

Timeline

- Final Design
 - Plans approved 9/19.
- Bid
 - 6-8 weeks
- Construction
 - Commence late 2025
 - Duration 12- 15 months
 - E470 contribution




Project Overview

 Design and construct bridge over E-470 for future Aurora Parkway extension to Parker Road

Timeline

- Design
 - Currently at 60% design
 - Ongoing monthly coordination meetings with roadway designers
 - Anticipate 12 18 months to complete final design in coordination with developers and trail designs
- Construction
 - Bridge construction will be bid when Aurora Pkwy is mass graded and initial stormwater protection measures in place
 - Anticipate 12 to 15 months construction duration


